On March 12, 2023, we will celebrate the 33rd Annual Allie Awards to be held at Hyatt Regency Atlanta and will present awards to leading individuals and companies in the event industry. Our finalists represent some of the most talented event professionals in the industry.

Over 40 coveted awards and honors encompassing more than 50 companies will be presented to the best in our industry at the annual gala event.

Allie Awards Inc. became a certified 501(c)(3) not-for-profit corporation in 2015 and is supported by a volunteer Board of Directors. The primary source of funding is generated from the annual event.

As of this past fall, we have filed to be renamed the Allie Foundation of Georgia, Inc. to bring clarity between the giving entity, the foundation and the annual event.

All net proceeds of the annual event will go toward scholarships established for Atlanta hospitality students. The first scholarship was distributed in 2017 and to date have contributed over \$25,000.00
